This Plan will protect your financial investment in the event that you must cancel or interrupt your travel, plus it provides the benefits of emergency medical treatment and emergency medical evacuation.

The SCI Travel Protection Plan consists of both insurance and non-insurance benefits.

Many unique features that you will be reimbursed for include, but are not limited to:

- *Out-of-pocket expenses for treatment associated with a medical or dental emergency that occurs during your trip.*
- *Cancellation or interruption of your trip if the government closes the game reserve, imposes a ban on hunting, or the hunting activity is declared illegal.*
- *Reimbursement for deposits/payments on hunting licenses, tag fees, government fees, arms fees, lottery fees, and governor's tags.*

SCI's Travel Protection Plan is administered for SCI by its insurance partners, Lechner & Stauffer and Sportsman's Insurance Agency. Insurance coverage is provided by World Access, the world leader in travel insurance since 1983. Evacuation services are provided by Global Rescue, an SCI sponsor.
